TRAINEES MAY BE CONSIDERED FOR THIS POSITION

Responsibility for the operation of a wastewater plant and for the routine maintenance and servicing of equipment and machinery at the plant. Employee exercises some independent judgment in making adjustments to machinery, equipment and related control apparatus in accordance with established procedures and standards. Works on an assigned shift.

QUALIFICATIONS:

Licensed applicants must possess a minimum Class "C" license from Florida State Department of Environmental Protection (DEP).

Knowledge of the general operation principles of electrical and mechanical equipment, similar to wastewater treatment and pumping plant equipment and machinery; some knowledge of the mechanical maintenance and lubrication requirements of the equipment operated. Knowledge of the occupational hazards of the trade and of proper use of safety procedures.

Ability to perform all required chemical analyses; inspect plant equipment and machinery to determine that all machinery is operating properly; take samples of wastewater at various stages of the treatment process; perform routine laboratory analyses to determine effectiveness of treatment procedures and records results.

Ability to inspect recorders and meters, and make necessary adjustments to control the operations as required; ability to make minor repairs to equipment operated. Ability to maintain detailed routine operating records.

Ability to accurately follow routine operating and recording procedures, and to understand and follow instructions. Ability to detect faulty operating characteristics in equipment or processes, and to institute remedial action.

Ability to establish and maintain effective working relationships with other City employees, department officials, and the general public.

Graduation from a standard high school or vocational school with supplemental college level courses in wastewater treatment or pollution control. Experience in the operation of electrical and mechanical equipment and machinery similar to that in a wastewater treatment plant. Licensed applicants are preferred. If hired as a Trainee, the applicant must pursue required courses for attainment of operator "C" License from the Florida State Department of Environmental Protection within a two year period from date of employment.

This position has been designated as "ESSENTIAL" for declared emergencies and must meet National Incident Management System (NIMS) training at the appropriate level. NOTE: This job classification is designated as a "safety sensitive" or "special risk" position, therefore an employee in this position is subject to random drug and/or alcohol testing as stated in the City of Plantation's Drug Free Workplace policy.
