## INTRODUCTION

The ~~1997~~ Comprehensive Plan for Plantation constitutes an update of the 1989 Plan. This plan is prepared to conform with State statute and administrative code (9J-5) requirements.

This Comprehensive Plan has been prepared in two volumes. Volume I constitutes the goals, objectives, policies and maps which the City Council adopted by ordinance. Volume II provides the data inventory and analysis that formed the basis for the plan.
