**TREE REMOVAL/RELOCATION PERMIT APPLICATION:  
COMMERCIAL & PLANNED RESIDENTIAL DEVELOPMENT**

**Please read these instructions before submitting the application**

- For a commercial property, the property owner must submit the application and sign the approved permit, in person. Property managers, contractors, arborists, and landscape companies may not submit the application or sign the approved permit on behalf of the property owner. Additional information and documentation may be required by the Department at the time of application submittal.
- For a Planned Residential Development (PRD) where landscape trees/palms are maintained by a Home Owners Association (HOA), the HOA President must submit the application and sign the approved permit, in person. An original signed and dated letter from the HOA (on letterhead with contact email and telephone number), authorizing the tree removal/relocation(s), must accompany the application form. Additional information and documentation may be required by the Department at the time of application submittal.
- Provide the required tree/palm information in the table on the reverse side for all trees/palms proposed for removal and/or relocation. A drawing of the property that clearly shows the locations of the trees/palms proposed for removal/relocation must also be submitted with this application form.
- If trees/palms are proposed for removal, provide a tree replacement plan by completing the required information in the table on the reverse side. Tree replacement is mandated by the City of Plantation pursuant to Section 13-44 of the City Landscape Code.
- As per Ordinance 2473, a Permit fee calculated at the rate of \$37.50 for each tree and palm removed and/or relocated, is to be paid at the time of application submittal. The application will be accepted and reviewed by the Department upon receipt of this form and appropriate payment. All applications must be submitted to the Department in person.
