## *Vendor Rules & Regulations*

For the health and safety of our patrons, vendors, and employees we kindly ask you to follow COVID 19 guidelines while attending Halloween in the Park.

Vendors will wear masks at all times.

This is a contactless event. Vendors will stay in their assigned spots.

Vendors will not approach patrons in vehicles.

Vendors will not distribute any candy or any items to patrons.

Vendors will limit the number of people participating in their spot to members of their “bubble”.

Vendor spaces will be assigned by the Parks & Recreation Department. No substitutions.

Vendors must provide their own supplies and decorations.

There is no electricity available at the vendor spots. Vendors will need to provide their own battery powered decorations or use their vehicle’s power.

Vendors must stay for the duration of event and remove all trash, decorations, etc.

Music will be broadcast at the event by the City.

Vendors may begin setting up at 2:00 pm and MUST be completed by 5:00 pm. Vehicles not decorated for the event must be moved to the designated parking area by 5:00 pm.

Rules may be subject to change.

## City of Plantation Event Waiver

### RELEASE AND WAIVER OF LIABILITY AGREEMENT

I waive any right that I may have to inspect and approve the finished product that may be used or to which it may be applied now and/or in the future, whether that use is known to me or unknown. I waive any right to royalties or other compensation arising from or related to the use of the image or product. In consideration for being permitted by the CITY to take part in the HALLOWEEN IN THE PARK, and participate in any activities connected with the HALLOWEEN IN THE PARK, the undersigned, releases, waives, discharges and covenants not to sue the CITY, its officers, agents and/or employees from and for any and all liability, claims, demands, and causes of action, including but not limited to attorney's fees and costs of suit, arising out of or relating to any injury, loss or damage, that may be sustained, whether caused by the CITY or otherwise. The undersigned is fully aware of the possible risks connected with the HALLOWEEN IN THE PARK and voluntarily assumes full responsibility for any risk of injury, loss or damage whether caused by the CITY or otherwise, to the full extent permitted by Florida law. I also agree to indemnify and hold harmless the CITY from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement with the HALLOWEEN IN THE PARK and to reimburse the CITY for any such expenses incurred, also subject to Florida law. It is the undersigned's express intent that this Release shall bind the undersigned and shall be deemed as a Release, Waiver, Discharge and Covenant not to Sue the CITY.

In signing this Release, the undersigned acknowledges and represents that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as a free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement have been made;
- C. I am at least (18) years of age and fully competent; and
- D. I execute this Release for full, adequate and complete consideration, i.e. permission to utilize the facility and/or participate in the event, fully intending to be bound by the same.
